In addition, the proposed internship must be formally approved by the applicant's home institution.</p> <p>Applicants who are not nationals of a country in which the specified language is an official or co-official language must demonstrate native-level proficiency in the language for which they are applying. Alternatively, they must have completed a minimum of ten (10) years of formal education in that language in a country where it holds official status. For the sole purpose of verifying compliance with this requirement, the selection committee may conduct an interview to assess the applicant's linguistic competence.</p>
